# Recommendations from the Special Roads Sub-Committee Meeting

Deputy Mayor Besley who is Chair of the Roads Sub-Committee spoke to the recommendation from the Roads Sub-Committee meeting regarding Structure 2013 located on 30 Sideroad.

Moved by Thwaites, Seconded by Hannon that Council accept the recommendation from the Roads Sub-Committee meeting held on October 2, 2019, and hereby authorizes Chris Knechtel of RJ Burnside and Associates to prepare the tender package for Structure 2013 so that it can be released in early 2020. Carried.

Craig reported that the winter salt/sand is in. Mayor White asked when the sign on 2<sup>nd</sup> Line SW would be replaced and Craig advised it would be done tomorrow. Mayor White also asked about the second entrance being installed on a farm on 260 Sideroad west of Corbetton and Craig advised that the original entrance is being removed once the house is built.

<u>Meeting with County Planners and OMAFRA regarding the Agricultural System Mapping</u> - Chris updated Council on his meeting and said there is nothing in the refinement criteria that is obvious for Melancthon. The mapping shows contiguous blocks of rural land and feels that Melancthon mapping is better than the Province's mapping.

During this time, Mayor White updated Council on the Special Meeting of County Council on September 26, 2019 dealing with four severance applications that the Township of Amaranth approved. He commented on each of the applications and then advised that motions were passed directing staff to prepare an appeal to the Local Planning Appeal Tribunal as the severances do not conform with the County's Official Plan and are inconsistent with the Provincial Policy Statement.

## Mulmur - Melancthon Shared FTE - Update

Councillor Thwaites updated Council on this matter and it appears that Mulmur is wanting to continue their enforcement with paid duty officers. It was noted that Mono may be interested in a further FTE to compliment what they already have and Grand Valley has also expressed interest. The process takes one year to 18 months to get a Full Time Equivalent Officer. It is an option, that Melancthon could also look at paid duty officers in the short term.

Councillor Thwaites also provided an update on the Joint PSB meeting held on September 27<sup>th</sup> with agenda items consisting of a Presentation from the Office of the Independent Police Review Director regarding Police Misconduct Complaints, Presentation on Cybercrime, discussion on traffic enforcement, Nottawasaga traffic enforcement model, photo radar, special constables motion by Mulmur Council and POA update.

#### Deputy Mayor Besley Reducing our Carbon Footprint

As this topic has been in the news lately regarding Climate Change, global warming, carbon footprint, etc., Deputy Mayor Besley asked himself what are we doing as a Municipal Council, to reduce our carbon footprint in Melancthon and that is the reason for adding this item to the Agenda. Discussion ensued and different suggestions were put forth on what Melancthon could do and has already done. For example, what we have done is, Melancthon has approved the installation of an electric charging station most recently. The streetlights in our subdivisions have been converted to LED and Melancthon was the first Township to purchase the Interim Tier 4 (Engine) John Deere Grader in 2012. A suggestion was made that we could host a "Carbon Footprint Day". Staff were directed to keep this item on the Agenda for discussion at each Council meeting. It was mentioned that a future goal to look forward to, is to have the Municipal Office and the Public Works building taken totally off the grid and run on solar panels.

#### Mayor White - Tour of the NWN Facilities

Mayor White advised Council that he had the opportunity earlier today to tour the NWN Facilities in Mississauga and Oakville. The one in Mississauga is a new 40,000 square foot finishing facility and the one in Oakville is a subsidiary facility. Mayor White advised that he was pleasantly surprised with the high level of work that goes on in the facility and the people employed there – DNA people and Scientists that test chemical components. At the end of the tour, he sat down with the Representatives and they asked what they should do to get this out to the public? Mayor White suggested that they get someone in there with a video camera of where they took him on the tour and provide it at their Open House. In the end, Mayor White was happy with what he saw.
