Unfinished Business

2025 Draft Capital and Operating Budgets, Sarah Culshaw, Treasurer

Mayor White and Deputy Mayor McLean gave an update on the County Council Budget meeting and advised that they both voted against the approval of the 2025 Budget.

Sarah Culshaw, Treasurer presented a third draft of Budget and reviewed her Budget summary, reserve schedules, development charge schedule, five-year capital plan, growth implications and impacts on assessment information with Council. The increase in this draft budget is 8.93% (6.85% with growth). Sarah advised that approximately 4% of the 6.85% increase presented is a result of the increases in recreation, OPP and

fire departments. Discussion ensured and it was determined that the 2024 surplus will be used to offset the cost of paving 260 Sideroad from Riverview to 2nd Line SW instead of splitting the project in half. After the changes made following the discussions the draft budget was brought down to 5.90% (3.82% with growth).

Reports/Updates from Members of Council & Administrative Staff

ROMA Delegation with the Minister of Transportation – Update

Mayor White, Deputy Mayor McLean and Councillor Plowright met with the Minister of Transportation for a Delegation at ROMA to discuss the traffic issues on Highway 10 and the intersection of Highway 10 and County Road 17. They felt that the meeting was productive.

<u>Denise Holmes – Email from Mulmur CAO regarding Team Building for the Mulmur Hockeyville competition – deadline is March 2nd).</u>

Denise Holmes, CAO/Clerk spoke to this item and advised that Tracey Atkinson, CAO for the Township of Mulmur had reached out asking if Melancthon Staff and Council would like to participate in a team building hockey game for the Kraft Hockeyville Challenge. Staff was directed to advise Tracey that we would be interested in participating.

<u>Councillor Neilson – Challenge Coin No. 2 Construction Battalion</u>

Councillor Neilson presented the Challenge Coin to Council that was provided to the Township by Alethia O'Hara-Stephenson's during the flag raising in recognition of Black History Month. The coin is presented to the Township of Melancthon in recognition of its ongoing collaboration with the Dufferin County Canadian Black Association (DCCBA) in ensuring Black history is recognized as an integral part of Canadian history. Given in appreciation of Melancthon's continued support for Black History Month and educational initiatives, this coin stands as a symbol of remembrance, resilience, and excellence.

Councillor Plowright advised Council that she had spoken with Township of Mulmur Mayor Janet Horner about the Horning's Mills Hall hosting the Strawberry Supper this year on Canada Day and the proceeds would be going to the Honeywood Arena Upgrades.
