SUBJECT: Staff Recommendation for Tender 01-2025

DATE: July 7th, 2025

The purpose of this report is to provide a recommendation for the award of Tender 01-2025 based on a thorough review of the submitted bids and the evaluation criteria established in the tender document.

The Township received four (4) bids for Tender 01-2025 from; IPAC Paving Inc, E.C. King Contracting, GIP Paving Inc and Cox Construction Limited.

While price is a key component of the evaluation, the Township also considers the following qualitative factors when awarding tenders:

- Previous experience working with the Township
- Track record and performance on past projects
- Proximity and presence in the local area
- Knowledge of site-specific conditions
- Overall value to the Township

Based on a review of the submitted bids and the evaluation criteria, it is recommended that the tender be awarded to **Cox Construction Limited**, the second-lowest bidder. While their bid was slightly higher than the lowest submission, the following factors support this recommendation:

- **Proven Track Record**: Cox Construction Limited has successfully completed several projects for the Township in the past and has consistently delivered high-quality work on time and within budget.
- **Local Experience**: The company has a strong presence in the area and is currently working on, or has recently completed, similar paving projects in

- nearby municipalities.
- **Familiarity with Site Conditions**: Their experience in the area gives them a practical understanding of the local road network and soil/geotechnical conditions, which is beneficial to project delivery and reduces risk of delays or unforeseen complications.
- **Positive Past Experience**: Township staff have found Cox Construction Limited to be professional, responsive, and efficient, with a history of excellent communication and cooperation throughout project delivery.

Given the combination of price competitiveness, local experience, and a solid history of positive project outcomes with the Township and neighbouring communities, it is recommended that **Cox Construction Limited** be awarded the contract for Tender 01-2025 at a price of **\$694,714.24** inclusive of HST.
